## **ELDERS PREPARE TO WIN PROMOTION 2024 TERMS AND CONDITIONS**

- 1. The promoter is Elders Rural Services Australia Limited (ABN 72 004 045 121) (**Elders**) of Level 10, 80 Grenfell Street, Adelaide SA 5000.
- 2. Elders' prepare to win promotion (**Promotion**) commences at 7:30am ACDT on Thursday, 1 February 2024 and closes at 6:00pm ACDT on Friday, 29 March 2024 (**Promotion Period**). Except as otherwise stated all times are ACST/ACDT (as applicable).
