## Terms and Conditions of Entry

1. The Elders Gateway to Greatness sale will be conducted under the ALPA Terms & Conditions (In Catalogue).
2. Sale entry fee of \$660.00 (INC GST) is due and payable with your Nomination Form. Nominations will not be catalogued until entry fees are paid for. Entry fees will not be refunded if the horse is withdrawn after cataloging without a vet certificate.
3. Elders Rural Services Marketing Fee of 8% + GST, will be charged on all lots sold and deducted from the Vendor's proceeds before settlement.
4. Horses nominated in the Elders Gateway to Greatness Sale must be 5yrs and over on date of sale.
5. Elders will have a Veterinarian on site at the Pre-Sale Inspections (Time & Date to be advised), random drug testing of sale horses on auction day will occur at the fall of the hammer.
6. Horses nominated in the Elders Gateway to Greatness Sale must be either a registered Australian Stock Horse or a registered Australian Quarter Horse.
7. If a horse's registration has not been finalised, Elders will not accept nominations.
8. The name of the registered owner of the horse must correlate with the name of the Vendor. If the Nomination is not in the Vendors name at time of entry the Nomination will not be accepted.
9. Original ASH or AQHA registration certificates and signed transfer forms must be provided at the pre-sale inspection.
10. Any Stallion or colts at time of sale must be Sire Registered and DNA recorded.
11. Any horse accepted as a colt cannot be sold as a gelding.
12. Vendors must ensure all information supplied at the time of Nomination are correct including, GST Status, contact details & settlement instructions.
13. Vendors must ensure all information supplied at the time of Nominations for horses is correct including, sex, DOB, registration status and brands.
14. Elders reserve the right to reject any horse that is not presented in suitable condition and/or if markings and brands described on the original registration certificate are not clearly visible and identical to the horse.
15. Vendors must disclose any nonstandard medical procedure (excluding general dental, castration, and branding). Horses with no disclosures or Vet certificate to state otherwise may be nominated for drug testing.
16. Vendors carry responsibility for ensuring that they inform Elders Auctioneers of any faults, defects or existing conditions that are not listed in the catalogue. To ensure that accurate disclosures can be made during the pre-works, Campdraft and at time of sale.
17. Performance Notes in the Catalogue are compulsory for all Lots and will be revised by Elders before Cataloguing.
18. GST. Vendors must complete the GST declaration requirements on the entry form. This information will be used for GST disclosure of individual lots in the catalogue. A hobby farm declaration will need to be filled out for those vendors that are not registered for GST.
19. Vendors agree that any person undertaking the handling of their sale lots from the time of arrival at Surbiton Station for the GTG Sale does so at their own risk whether they be a strapper, handler, trainer, rider and the like. An equestrian helmet approved by the Australian Standards Association or International equivalent, with chin strap securely fastened, MUST be worn by all riders under the age of 18 years, always, when riding horses at Surbiton Station. Under no circumstances is a rider under 18 years permitted to ride a stallion.
20. Vendors agree to be bound by all decisions of the Elders Rural Services regarding conduct of the horse workouts, sale display and penning of sale lots, and the lotting of catalogue sale order. Vendors also agree that Elders Rural Services reserve the right to amend and edit any vendor notes supplied for lots as they determine, for printing in the catalogue.
21. Vendors who breach the sale conditions of entry or whose actions are considered not in the best interests of the sale will not be invited to participate in future sales.
22. Post sale X-rays & vet checks will not be grounds for reversal or rescinding of sale. Any post sale claims or disputes will strictly be a matter between the Vendor & Buyer. If a sale is reversed or rescinded Elders Rural Services reserve the right to retain the commission of the sale.
23. If insufficient nominations are received by Elders there will be full nomination refund and this will be shared within 2-3 weeks of nominations closing.

### Pre-Sale Inspections

24. Vendors are required to supply the following documents at pre-sale inspections fully filled in and signed;
  - (a) Biosecurity Horse Health Declaration
  - (b) Movement Record
  - (c) Original Registration certificates & transfer papers.

### Campdraft

25. Horses will have an automatic nomination into the Elders Gateway to Greatness "Sale Horse" Incentive Campdraft.
26. This campdraft will be exclusive to sale horses for the first year of the Gateway to Greatness Sale, future incentive campdrafts will only be for horses purchased at the Elders Gateway to Greatness sale. On offer will be \$50,000 in prize money split over 1 Round & Final, Sale horses will be eligible for the Incentive campdraft for 3 years.
27. Horses purchased in the Elders Gateway to Greatness sale will be eligible for 3 years providing they remain in ownership of the original purchaser and present registration certificates upon nominating.
28. Any Lot that competes in the Incentive campdraft but withdraws before the sale will need to present sale horse to the Elders Veterinarian before prize money/s can be released.
