ELDERS ULTIMATE GRAND FINAL WEEKEND PROMOTION 2024 TERMS AND CONDITIONS

- 1. The promoter is Elders Rural Services Australia Limited (ABN 72 004 045 121) (**Elders**) of Level 10, 80 Grenfell Street, Adelaide, SA, 5000.
